Message from the Chief

I am pleased to present the 2017 Annual Report for the Belmont, Foster City and San Mateo Fire Departments. You will find pertinent details about our organization and the services we provided to the community during the year. We continue to celebrate our proud history, while we look forward and chart our future. The year 2017 will definitely be noted in history as a year with numerous significant disasters in our Country. Floods, hurricanes and wildfires became the norm this year. I am proud to report our organization rose to every challenge locally, throughout the State, and nationally.

Our primary focus this past year was developing the terms to bring our three fire departments together as one. All the hard work by many proved successful. The City Councils of all three Cities passed resolutions to begin formation of the San Mateo Consolidated Fire Department. This new Joint Powers Authority Fire Department is planned to commence operations July 1, 2018, once we have completed approval from Cal PERS and enter into other necessary agreements for services. Our Bureau of Fire Protection and Life Safety Division has standardized their services to all three Cities and moved their office space to 1900 O'Farrell Street, Suite 350, in San Mateo to be centrally located to provide service.


The communities we serve are experiencing a great deal of growth and development, including improvements to infrastructure. Some of the more notable projects include the Cal Train grade separation for 25th, 28th and 31st Avenues that have begun, along with the Waste Water Treatment Plant replacement project, Cal Trans Hwy 92 and El Camino Real interchange, and the PG&E pipeline replacement on Ralston Avenue. Increasing traffic concerns have us working with SamTrans and our neighboring Cities for grant funding for improvements that will aid us in maintaining our emergency response service delivery time standards. Each year the number of our emergency responses increase, with 2017 increasing by 650 more calls for service (4.6%) over 2016. Fortunately, we have maintained a 95% compliance in meeting the County response time standard.

Safety remains our organization's top priority. We have continued to implement best practices on reducing exposure to cancer causing toxins and have devoted a great deal of time focusing on improving behavioral health needs of all our members.

Other accomplishments of 2017 include all three Cities maintaining our ISO rating of Class 2 Fire Department, which places our Departments in the top 3.42% of all fire departments rated in the United States. We updated all three Cities' Local Hazard Mitigation Plan and continued to educate both City employees and the community members in emergency preparedness. We also continued to maintain a modern fleet, ordering three more Pierce Engines and one more Seagrave Engine that are going to be delivered in the fall of 2018. WLC Architects completed design for a new Fire Station 25 to be located on the corner of Shafter and Borel, two blocks from the existing Fire Station 25. We hope to break ground on this project in the summer of 2018.

On behalf of all the fire department members, I want to thank you for all the trust and support and wish you a safe and happy 2018.

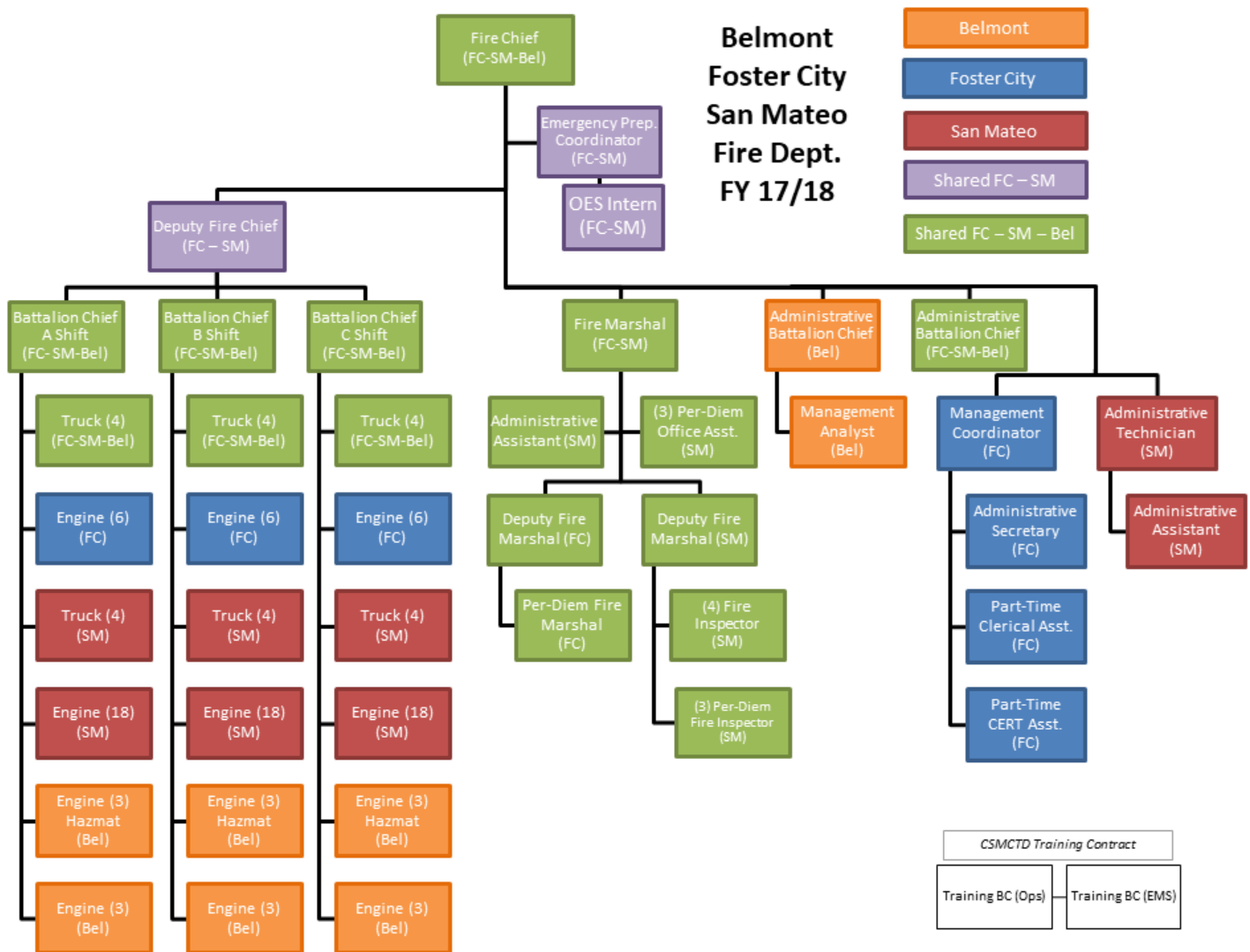

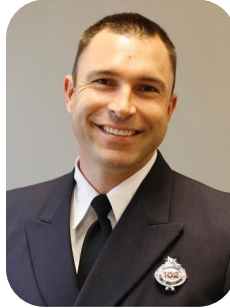

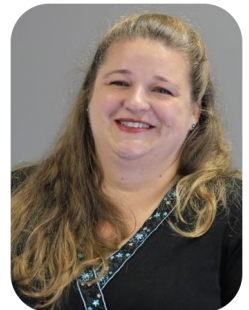
**Fire Inspector Christina daSilva

Mark Harvey (San Mateo)

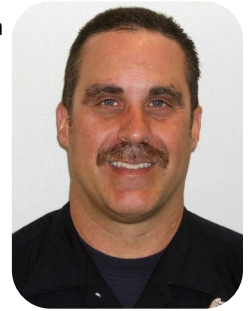

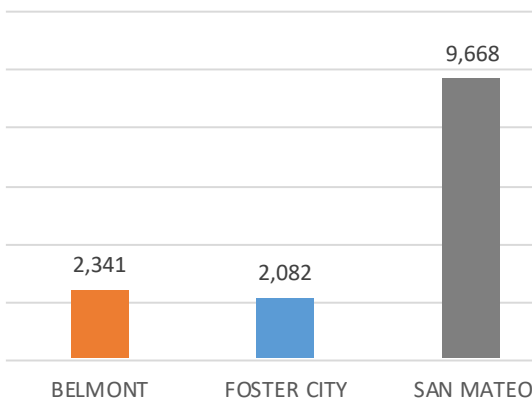
Average Response Time by Agency
(Only includes: Priority 1 & First Ins)



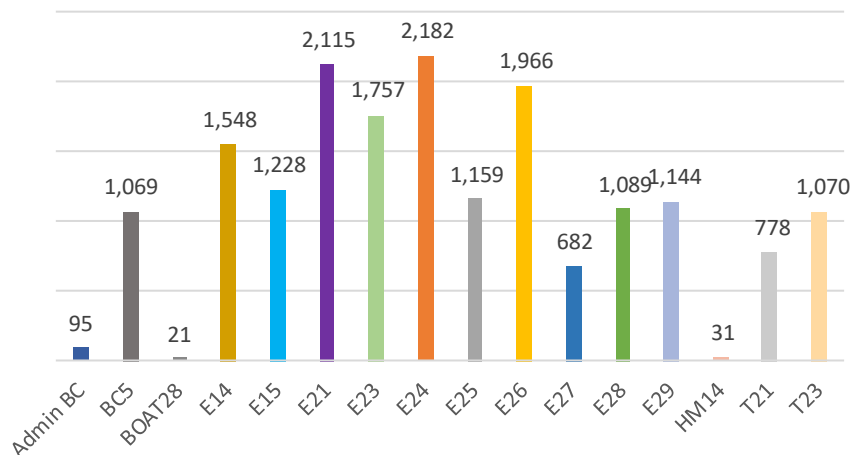
Incident count by Type (14,871 Total)

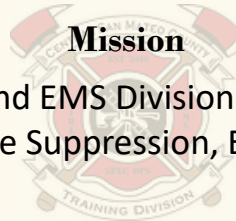

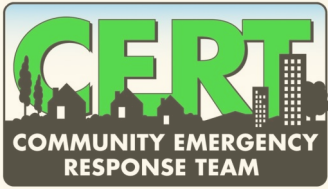
The COFC Community Emergency Response Team (CERT) currently has over 400 members, all sworn Disaster Service Workers. Many members are HAM radio operators and have taken additional training classes such as CPR and First Aid. This year the team was proud to present over 48 continuing education classes or events to the membership. The events included San Mateo County's annual Silver Dragon neighborhood distribution event and their Disaster Preparedness Day; a large activity booth at CityFest, and three big Skills Day events. FC CERT also participated in the state-sponsored Urban Shield exercise, a major training event for first responders. In October, CERT assisted the Red Cross with the installation of over 300 smoke detectors in the homes of Foster City residents.

Office of Emergency Services

San Mateo | Foster City

In 2017, the Office of Emergency Services continued to broaden emergency preparedness stakeholder engagement by consistently interacting with the community, city departments, and local, regional and state emergency preparedness stakeholders. OES proudly accepted City Council Proclamations in both Foster City and San Mateo in honor of National Emergency Preparedness Month in September 2017.

Training

In San Mateo, OES continues to present information related to Disaster Service Worker status at San Mateo's quarterly New Hire Orientation and distributed backpacks and disaster preparedness information to over 80 newly hired merit employees. In 2017, OES worked with all City departments to ensure compliance with the National Incident Management System training requirements, and training certificates were obtained by over 90 staff members from Foster City, and San Mateo. During September's National Emergency Preparedness Month, OES organized a "Get Ready" Disaster Preparedness classes attended by 12 San Mateo City Staff, and offered the second annual City Staff CERT Academy attended by 25 San Mateo City Staff. Both Foster City and San Mateo participated in Emergency Operations Center table top exercises, focusing on severe winter storms. The exercises tested the core capabilities of Situational Assessment, Operational Coordination, and Critical Transportation. Lessons learned from the exercises will be used to develop future trainings and improve emergency planning efforts.

OES and other Foster City and San Mateo city staff participated in the Bay Area Urban Area Security Initiative (BAUASI) Yellow Command Table Top exercise on June 29, 2017 focusing on Mass Care Services. In coordination with the American Red Cross, OES offered 3 Shelter Operations and Management courses to Parks and Recreation staff to prepare for an emergency shelter exercise titled, "The Heat Is On" to test the core capability of Mass Care Services. Using the emergency shelter equipment procured by San Mateo in 2016, members of the San Mateo Parks and Recreation staff, San Mateo CERT, and American Red Cross set up a mock shelter in the San Mateo Senior Center on September 7, 2017. The exercise was observed by the Foster City and Belmont Parks and Recreation Staff, and lessons learned will be used to build additional shelter capabilities.

Local Hazard Mitigation

The process to revise San Mateo's Local Hazard Mitigation Plan (LHMP) continued into 2017. San Mateo's multi-departmental planning team received comments on the draft LHMP from the California Governor's Office of Emergency Services (CalOES) on April 11, 2017. This plan was ultimately approved by FEMA and adopted San Mateo's City Council on June 5, 2017.

Collaborations

In 2017, OES participated as a member of the San Mateo County Emergency Managers Association in many initiatives in collaboration with the San Mateo County Operational Area, including review and revision of several Operational Area Emergency Operations Plan Functional Annexes. OES also supported the San Mateo County Health System in facilitating the Skilled Nursing Facility Tabletop Exercise on January 25, 2017.

OES continues to engage with the community on matters of emergency preparedness, including the California Resiliency Alliance through its Private Sector Advisory Committee, through the Foster City and San Mateo Chambers of Commerce, and through both the San Mateo City Services Academy and Leadership Academy. Additional engagement was achieved through public education and outreach to community groups such as the Boy Scouts, commercial property managers, neighborhood associations and others.

OES and the San Mateo Fire Prevention Bureau partnered with the American Red Cross Home Fire Preparedness Campaign for the second year in a row to deliver two successful smoke alarm

installation events held on September 23 and October 28, 2017. The installations took place throughout both San Mateo and Foster City focusing on the senior citizen population. In 2017, this partnership reached 73 households comprised of 168 residents, and 318 smoke alarms were installed.

The Office of Emergency Services continues to engage other city departments including the Public Works, Police, Community Development and Parks and Recreation in the development of a Winter Storm Response Plan. OES created an Incident Action Plan (IAP) and led Foster City departments of public works, parks and recreation, police and fire in the partial activation of the Foster City Emergency Operations Center (EOC) to support the City's annual Independence Day Celebration. In 2017, San Mateo incurred expenses related to winter storm responses associated with federally declared disasters 4305 and 4308. OES facilitated the application to FEMA for reimbursement of eligible storm related expenses resulting in cost recovery of over \$27,000.

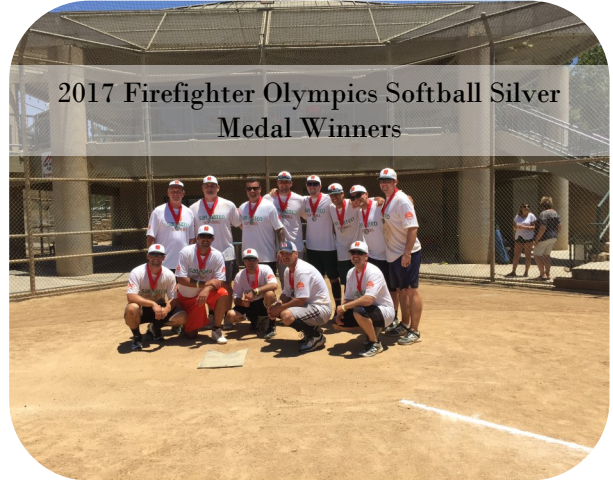

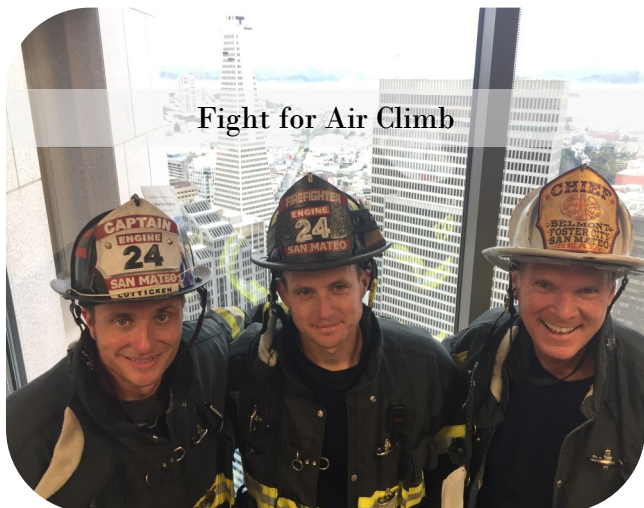
The Belmont & Redwood Shores Rotary Club sponsored a "Battle of the Badges" Softball game between Belmont Fire and Police Departments.

Bureau of Fire Protection & Life Safety

Mission

The Belmont Fire Bureau is responsible for the management and enforcement of all City fire and life safety codes. - 710 Island Parkway– Autobahn Motors Mercedes-Benz lounge area for customers to wait while their cars are being serviced. Cars will be dropped off for service and transported across the street. To be completed early 2018.
- 1201 Shoreway Road– Hampton Inn and Suite– Hotel rooms with parking on the first floor. To be completed by the end of 2018.
- 1001 Old County Road– Gas Station and Car Wash– Gas Station will have unleaded and diesel gasoline.

The inspections include but are not limited to; fire sprinkler systems, fire alarm systems, hazardous material handling, use and storage, additionally, verify that all life safety systems are provided and are adequately maintained. The Bureau also provides fire loss investigations to determining the origin and cause of fires.

Major 2017 Projects/Accomplishments:

Completed construction

- 1199 Chess Drive– Marriott Extended Stay Hotel– 112 room hotel completed.
- 1299 Chess Drive– Strip mall type commercial with Habit Burger, FedEx, Mod Pizza & Panera Bread completed early 2017.
- 707 Thayer Lane– Atria Assisted Living– Located next to City Hall consisting of 155 apartments and 24 dementia units. Commercial businesses on the first floor are in the process of tenant improvements .
- Alma Point– 5 story senior apartments with commercial below. The 66 apartments are complete and retail businesses are in the tenant improvement process. New Starbucks currently open for business.
- 100 Grand Lane– Commercial tenants are complete with only one space still unoccupied.
- 353 Vintage Park Drive– Gilead Sciences– Remodeled this office building and it now houses office space for the company.

Under construction

- Illumina– Biotech located at E. Third and Lincoln Center– 3 of the 4 buildings are almost ready for tenant improvements with occupancy expected in early 2018. A high-rise will finish the buildings but yet to start the planning phase. 1 of the 3 parking structures is almost ready for use.
- 355 Lakeside– Gilead is moving along with the 5-story research and development lab building. It will be very similar to the existing building at 357 Lakeside and will be connected by pedestrian bridges.
- 324 Lakeside is also a Gilead building and will be labs and offices housed in a 4-story building.
- 1166 Triton– The Triton– Very close to completion of 220 apartments. There is an attached parking garage and the front part of the first floor will house commercial space, which has yet to be determined.
- Foster Square Condominiums– Still in construction with 3 of the 14 buildings occupied. These are 4 story buildings with large 2-story condos averaging 8-12 units per building.
